- VI. Information Items
 - A. Introduction of Mary Ann Degginger, new executive director Degginger commented on the first month in her new role with the organization and fielded questions from Trustees.
 - B. Review by Executive Director of April GCLD Department Highlights & Statistics

Degginger welcomed Jeanette McQuade, branch manager at Fraser Valley Library, who spoke about the library and its activities. Degginger provided a summary of April's projects, events, and statistics, with a focus on library visits and program attendance. The extended access program will be ready to pilot in Hot Sulphur Springs soon. Solar charging stations have been ordered for Kremmling, Granby, and Fraser Valley. A summary of future opportunities was shared with Trustees, including land options in Kremmling for the library project. The apartment renovation is almost complete.

- D. Summer Library Program Update

Chris Newell provided a report about the end of Book Madness and the start of the Summer Library Program, formerly Summer Reading Program. The program structure was highlighted including design, special performances, and completion incentives for library visitors of all ages, including adults.

E. Juniper Library siding repair/restoration project

Purchase request for Juniper siding vendor - two quotes have been received from different vendors for phase two. Phase one of this project was completed last year. Degginger explained and summarized the work included in both vendor quotes. One option offers maintenance of the current bark. Second option includes blasting off the bark and restoring the log. The maintenance director would choose to preserve the aesthetic and match the work done last year. Trustees discussed both options.
