 - A. Juniper Library Director Report

Sue Luton, branch manager, reported on things happening at the library. Staff commented that it's fun to see families working together - young children through grandparents helping each other learn how to use the library. Rob Cullen and Wells Squire gave the June update about the Community Needs Assessment & Facility Master Plan project. July's meeting will provide detailed capital budgetary recommendations. A near-final draft report will be ready for the August meeting. Rob and Wells fielded questions from Trustees.

D. Sunsetting Mill Levy Presentation

Thompson presented a mill levy analysis and explained the processes required to put a ballot initiative forward in November. A Resolution will be required by the July Board meeting to move forward with a ballot initiative if it is deemed necessary. Property values have spiked in Grand County leading to an excess revenue compared to what was anticipated. Trustees discussed scenarios and asked questions about revenues and projected expenditures moving forward. The Finance Committee will discuss the mill levy option during their meeting on July 7 and provide a recommendation.

- E. Board Training Opportunities Discussion
 Krones presented an idea for training being offered by the American Library
 Association. If an opportunity arises that has an expense attached, please
 reach out to staff so funding can be considered. There was a request for
 more virtual training opportunities. Input from Trustees was solicited to
 gauge interest in future professional development.
- F. Kremmling Library building project update
 There has been engagement with realtors in Kremmling. There is nothing
 new to report regarding land acquisition. Trustees discussed the project and
 the need to work diligently to make progress on the plans. Recommendations
 and ideas were shared about ways to drive the process forward. There was
 agreement that we need to be proactive and consider a project coordinator
 to manage the actual building project. Land acquisition is a priority.

 Degginger was asked to have an official report available for the July meeting
 regarding land acquisition so that Trustees can make decisions moving
 forward.
